



Checklist for visa application in Georgia for drivers conducting international cargos and passenger transportation

(to the territories of the Member States in vehicles registered in Georgia)

Applications should be submitted in person (also babies and children) and the following documents must be submitted:

- For every document, you must provide the original and one copy.
- The documents are to be presented in (or translated to) Dutch, English, French or Spanish.
- The documents submitted will not be returned. Only the travel document will be returned.

1. Application

- 1.1 A completed and signed Schengen [visa application form](#).

2. Travel Documents

- 2.1 A passport or other travel document.

Please note:

- Your passport or travel document must be valid for at least 3 months from the date on which you leave the Schengen area.
- Your passport or travel document must have at least 2 empty visa pages.
- Your passport or travel document cannot have been issued more than 10 years ago.

- 2.3 Specific requirement for minors: The consent of the parental authority or legal guardian should be required only if the minor travels alone or only with one parent.

Obviously exceptions should be made to this, if the single parent with whom the minor is to travel holds the parental authority alone.

- 2.4 Specific requirement for minors: Proof that a single parent holds parental authority alone.

5. Proof of travel

Note: make travel reservations which you can cancel, in case your visa request will be refused.

- 5.1 A written request from the national company or association of carriers of Georgia providing for international road transportation, stating the purpose, duration and frequency of the trips.
A certificate proving that the company is authorised to provide international road transportation services.

If the costs are covered by the employer: employer's bank statement demonstrating the last three months' account movements. If the driver covers the costs: his/hers bank statement demonstrating the last three months' account movements.
